

RESOLUTION NO. 02-07-2023

A RESOLUTION OF THE JERSEY SHORE AREA JOINT WATER AUTHORITY AMENDING RESOLUTION 84-2, AS PREVIOUSLY AMENDED BY RESOLUTION 87-10-19, RESOLUTION 91-11-18, RESOLUTION 99-11-15, RESOLUTION 05-11-21, RESOLUTION 06-10-16, RESOLUTION 2011-04-18, RESOLUTION 2017-06-19, RESOLUTION 2019-10-21, RESOLUTION 2021-04-19, RESOLUTION 2022-06-17-A, RESOLUTION NO. 3-21-22, RESOLUTION NO. 07-18-2022B, AND RESOLUTION NO. 9-19-2022 ESTABLISHING WATER RENTS, RATES AND CHARGES FOR FURNISHING WATER SERVICE TO CONSUMERS SERVED OR TO BE SERVED THROUGH THE WATER SYSTEM OWNED BY THIS AUTHORITY; PROVIDING FOR PAYMENT AND COLLECTION OF SAID WATER RENTS, RATES AND CHARGES AND THE ENFORCEMENT THEREOF; ADOPTING CERTAIN RULES AND REGULATIONS APPLICABLE TO THE WATER SYSTEM AND AUTHORIZING ADOPTION OF ADDITIONAL RULES AND REGULATIONS APPLICABLE TO THE WATER SYSTEM.

WHEREAS, the Board of the Jersey Shore Area Joint Water Authority (the "Authority"), has reviewed the necessity for an increase in charges in order to meet expenses of the Authority; and

WHEREAS, the Board of the Jersey Shore Area Joint Water Authority is desirous of amending its water rates and charges structure in accordance with the terms set forth herein.

NOW, HEREBY, BE IT ENACTED AND RESOLVED that the following sections of Resolution 84-2, as amended by Resolution 87-10-19, as amended by Resolution 91-11-18, as amended by Resolution 99-11-15, as amended by Resolution 05-11-21, as amended by Resolution 06-10-16, as modified by Resolution 2011-04-18, as amended by Resolution 2017-06-19, as amended by Resolution 2019-10-21, as amended by Resolution 2021-04-19, as amended by Resolution 2022-01-17A, as amended by Resolution No. 3-21-22 as amended by Resolution No. 07-18-2022B, and Resolution No. 9-19-2022 be amended as follows:

SECTION 1.

Section 1 shall be amended to include a new Schedule E which shall read as follows:

"All customers shall be charged a flat rate of Ninety (\$90.00) Dollars for all service calls after normal business hours, including holidays and weekends. In the event a customer fails to appear for a pre-scheduled appointment and fails to cancel the appointment at least one (1) hour prior to the scheduled appointment, a Twenty-five (\$25.00) Dollar service fee shall be imposed."

SECTION 2. SAVINGS CLAUSE.

In all other respects, the aforesaid Resolution 84-2, as amended by Resolution 87-10-19, as amended by Resolution 91-11-18, as amended by Resolution 99-11-15, as amended by Resolution 05-11-21, as amended by Resolution 06-10-16, as modified by Resolution 2011-04-18, as amended by Resolution 2017-06-19, as amended by Resolution 2022-1-17A, as amended by Resolution No. 3-21-22, as amended by Resolution No. 07-18-2022B, and Resolution No. 9-19-2022 shall remain in effect except as otherwise amended herein.

SECTION 3. SEVERABILITY.

It is hereby declared to be the intention of the Board of the Jersey Shore Area Joint Water Authority that the parts, sections, paragraphs, sentences, clauses, and phrases of these amendments and additions are severable. If any section, paragraph, sentence, clause, or phrase of this Resolution, its amendments and additions, is declared unconstitutional, illegal, or otherwise invalid by the judgment or decree of a court of competent jurisdiction, that invalidity shall not affect any of the remaining parts, sections, paragraphs, sentences, clauses, or phrases of this Resolution, its amendments or additions.

SECTION 4. EFFECTIVE DATE.

This Resolution shall take effect immediately.
