

RESOLUTION NO. 07/18/2022 B

A RESOLUTION OF THE JERSEY SHORE AREA JOINT WATER AUTHORITY AMENDING RESOLUTION 84-2, AS PREVIOUSLY AMENDED BY RESOLUTION 87-10-19, RESOLUTION 91-11-18, RESOLUTION 99-11-15, RESOLUTION 05-11-21, RESOLUTION 06-10-16, RESOLUTION 2011-04-18, RESOLUTION 2017-06-19, RESOLUTION 2019-10-21, RESOLUTION 2021-04-19, RESOLUTION 3-21-22, AND RESOLUTION 2022-06-17-A ESTABLISHING WATER RENTS, RATES AND CHARGES FOR FURNISHING WATER SERVICE TO CONSUMERS SERVED OR TO BE SERVED THROUGH THE WATER SYSTEM OWNED BY THIS AUTHORITY; PROVIDING FOR PAYMENT AND COLLECTION OF SAID WATER RENTS, RATES AND CHARGES AND THE ENFORCEMENT THEREOF; ADOPTING CERTAIN RULES AND REGULATIONS APPLICABLE TO THE WATER SYSTEM AND AUTHORIZING ADOPTION OF ADDITIONAL RULES AND REGULATIONS APPLICABLE TO THE WATER SYSTEM.

WHEREAS, Jersey Shore Area Joint Water Authority (hereinafter "Authority") is a duly organized Pennsylvania municipal authority, pursuant to the provisions of the Pennsylvania Municipal Authorities Act, currently codified at 53 Pa. C.S.A. §5601, et seq., (hereinafter "Act");

WHEREAS, the Authority has reviewed the necessity to amend its Rate Resolutions to include provisions concerning tapping fees and connection fees;

WHEREAS, Section 5607 of the Act, as amended (sometimes referred to as Act 57), permits the Authority, inter alia, the power to establish tapping fees and connection fees to provide water services to its customers;

WHEREAS, the Authority has undertaken to have a tapping fee study performed by its engineer, Larson Design Group, in accordance with Section 5607 of the Act; and

WHEREAS, the Authority is desirous of adopting a tapping fee and connection fee schedule.

NOW, THEREFORE, BE IT RESOLVED that the following sections of Resolution 84-2, as amended by Resolution 87-10-19, as amended by Resolution 91-11-18, as amended by Resolution 99-11-15, as amended by Resolution 05-11-21, as amended by Resolution 06-10-16, as modified by Resolution 2011-04-18, as amended by Resolution 2017-06-19, as amended by Resolution 2019-10-21, as amended by Resolution 2021-04-19, and as amended by Resolution 2022-01-17A, Resolution 3-21-22 and Resolution 2022-06-17-A, shall be amended to delete and replace former Section 4 and Section 5 with a new Section 4 and Section 5 and renumber former Sections 4 and 5 as new Sections 6 and 7 as follows:

SECTION 4. TAPPING FEES.

Each property owner desiring to connect to the Authority's water distribution system, prior there to, shall pay a tapping fee as follows:

5/8"	\$ 3,500.00
3/4"	\$ 5,250.00
1"	\$ 8,750.00
1 1/2"	\$ 17,500.00
2"	\$ 28,000.00
3"	\$ 56,000.00
4"	\$ 87,500.00
6"	\$175,000.00
8"	\$280,000.00

SECTION 5. CONNECTION FEES.

In addition to the tapping fees set forth above, all property owners desiring to connect to the Authority's water distribution system shall pay a connection fee equal to the actual construction cost plus an overhead fee of twenty (20%) percent.

SECTION 6. SAVINGS CLAUSE.

In all other respects, the aforesaid Resolution 84-2, as amended Resolution 87-10-19, as amended by Resolution 91-11-18, as amended by Resolution 99-11-15, as amended by Resolution 05-11-21, as amended by Resolution 06-10-16, as modified by Resolution 2011-04-18, as amended by Resolution 2017-06-19, as amended by Resolution 2019-10-21, as amended by Resolution 2021-04-19, and as amended by Resolution 2022-01-17A, Resolution 3-21-22, and Resolution 2022-06-17-A, shall remain in full force and effect, except as otherwise amended herein.

SECTION 7. SEVERABILITY.

It is hereby declared to be the intention of the Board of the Jersey Shore Area Joint Water Authority that the parts, sections, paragraphs, sentences, clauses, and phrases of these amendments and additions are severable. If any section, paragraph, sentence, clause, or phrase of this Resolution, its amendments or additions, is declared unconstitutional, illegal or otherwise invalid, by a judgment or decree of a court of competent jurisdiction, that the invalidity shall not affect the remaining parts, sections, paragraphs, sentences, clauses, or phrases of this Resolution, its amendments or additions.
