

**RESOLUTION NO. 10-03-2025**

**A RESOLUTION OF THE JERSEY SHORE AREA JOINT WATER AUTHORITY  
AMENDING RESOLUTION 05-07-2024 ESTABLISHING WATER RENTS, RATES  
AND CHARGES FOR FURNISHING WATER SERVICE TO CUSTOMERS SERVED  
OR TO BE SERVED WITH A WATER SYSTEM OWNED BY THIS AUTHORITY  
RELATED TO THE IMPOSITION OF TAPPING FEES.**

WHEREAS, the Board of the Jersey Shore Area Joint Water Authority (the  
"Authority"), has reviewed the necessity for an increase in tapping fee in order to meet  
expenses of the Authority; and

WHEREAS, the Board of the Jersey Shore Area Joint Water Authority, after study of  
the necessary revenue needed to be raised in order to meet ongoing costs and capital  
expenditures for the Authority to maintain its water system, has reviewed the present tapping  
fee structure; and

NOW, HEREBY, BE IT RESOLVED THAT Resolution 05-07-2024 is  
amended as follows:

SECTION 1: SCHEDULE G of Resolution 05-07-2024 is Hereby Amended as  
follows:

**SCHEDULE G. TAPPING FEES**

1. Each property owner desiring to connect the Authority's water system, prior  
thereto, shall pay a tapping fee as follows:

<u>Size of Meter</u> (Inches)	<u>Tap Fee</u>
3/4	\$5,250.00
1" or greater	\$5,250.00 x projected equivalent daily usage (EDU)

SECTION 2. SAVINGS CLAUSE:

In all other respects, Resolution 05-07-2024 shall remain in full force and effect to the extent not inconsistent herewith.

SECTION 3: REPEALER PROVISION.

All Resolutions or parts of Resolutions which are inconsistent herewith are repealed.

SECTION 4. SEVERABILITY.

It is hereby declared to be the intention of the Board of the Jersey Shore Area Joint Water Authority that the parts, sections, paragraphs, sentences, clauses, and phrases of these amendments and additions are severable. If any section, paragraph, sentence, clause, or phrase of this Resolution, its amendments and additions, is declared unconstitutional, illegal, or otherwise invalid by the judgment or decree of a court of competent jurisdiction, that invalidity shall not affect any of the remaining parts, sections, paragraphs, sentences, clauses, or phrases of this Resolution, its amendments or additions.

SECTION 5: EFFECTIVE DATE:

This Resolution and the terms confirmed herein shall become effective

October 3, 2025.
